As we move into a new year with exciting possibilities and challenges, Delta Kappa Gamma International, Eta State, and the Beta Delta Chapter offer grants, scholarships, and professional development funds for our members. For instance, the Shaw-Lewis Beginning Teacher Grant awards \$500 each spring to a female teacher in Guilford County. The Dr. Ann Joyce Reardon Award is available to chapter members seeking personal and professional development experiences, and the award is up to \$500. If a member is pursuing a master's or doctoral degree, Delta Kappa Gamma offers \$6,000 scholarship for a master's and \$10,000 scholarship for a doctoral candidate. 

Happy New Year, Y'all, from your Chapter Treasurer!

Here are some DKG financial matters that you will be interested in: Congratulate yourselves for raising a total of \$2,613.00 at our December brunch. Of that total, we paid Sedgefield Country Club, \$755.79 to cover the cost of the brunch. We are already using the proceeds of our auction to help fund many worthy causes. At the state level, Beta Delta sent a \$200 check to our Eta State Scholarship Fund. Additionally, a \$108 check was sent to the State Headquarters Fund (which is \$2 per Beta Delta member). 

STRENGTHENING SOCIAL SECURITY ACT OF 2013

Although the Strengthening Social Security Act of 2013 (S.567, H.R.3118) has been introduced in both houses, it has been referred to a committee and will probably not be acted on in this session of Congress. This act is designed to help Social Security increases keep up with increases or decreases in the cost of living through several sources of information.

ENGLISH AS OFFICIAL LANGUAGE ACT

In September 2014 H.R. 5473 was introduced in the House of Representatives. This bill would establish English as the US "official" language in all governmental matters. The only exceptions are for (1) religious purposes, (2) language training for international communication, or (3) school programs designed to encourage students to learn foreign languages. I assume this could affect "English as a second language" programs.

OTHER RECENT LEGISLATION OF INTEREST

A surprising number of bills were filed in September 2014. To get more information about specific legislation go towww.congress.gov for bill summaries and full text of the bills.

PROTECTING STUDENTS FROM WORTHLESS DEGREES

An interesting bill introduced in September 2014 is H.R.5572 entitled Protecting Students From Worthless Degrees Act. This bill makes institutions of higher learning ineligible to receive federal funds if the institution does not provide training for specific occupations for which jobs exist, and also directs institutions to help students with job placement in these occupations. This bill is almost certainly the result of young people taking out student loans to attend schools which are making extravagant claims about job opportunities. Then when the student tries to get employment in the field for which he/she was supposedly trained, finding that no jobs are available in the field.

Delta Kappa Gamma Eta State Education Law and Policy Committee Protocol for Political Contacts

Participation in the political process is both a right and a responsibility. As Eta State seeks to influence legislative decisions at local, state, and national levels, it is important that we acknowledge the purposes of our society and the dignity of our profession. With this purpose in mind, members are asked respectfully to remember the following guidelines:

- All Eta State communications with legislators and staff will be cordial and professional.
- When representing DKG, members will confine remarks to the issues identified by the membership. Other issues may be addressed at a different time as individuals or members of another group.
- DKG members will educate themselves on the specific legislation/policy to be addressed as well as appropriate background to support our position.
- All letters to the editor addressed to local newspapers/news sources will be submitted after the approval of the local chapter.
 - It is suggested that all letters be reviewed by an additional reader.
 - In order to reassure members, chapters may prefer that all Letters to the Editor be signed by retired members.
 - Copies of all letters to the editor will be sent to the Eta State President.
- When attending meetings with office holders either locally or in their legislative offices, DKG members will wear their membership pins.

All emails regarding political activity will be sent to members' personal email addresses and not to email addressed associated with a school system or state agency.
